Arrival Procedures

PLAN TO ARRIVE BETWEEN 3 PM AND 8 PM FRIDAY

Camp Rilea is located in Warrenton, OR, about 7 miles north of Seaside and 10 miles south of Astoria on the Oregon coast.

- 1. From Hwy 101 northbound or southbound, take the Camp Rilea exit (33168 Patriot Way) to enter the camp.
- 2. Stop at the guard gate to show ID (driver only).
- 3. Proceed to McCarter Rd and take a left. Park in front of the barracks.
- 4. Unit leader will check in with the registrar inside the barracks to confirm the unit roster and turn in signed photo release. Scouts will receive:
 - an Exploration merit badge workbook
 - a notebook for taking notes
 - info on their cohort assignment
 - a bay (bunk) assignment
 - blue card to be filled out as part of registration

About Fort Clatsop

92343 FORT CLATSOP ROAD ASTORIA, OR 97103

Fort Clatsop is a national memorial marking the site of the encampment where the 33-member Lewis and Clark expedition wintered among the Clatsop people from December 7, 1805, until March 23, 1806. After staying here, the Corps of Discovery started their return journey to St. Louis.

The park includes the 2006 replica of the 50 foot square fort (the original had succumbed to decay in the wet climate); a visitor center with exhibits, bookstore and theater; historic canoe landing, and a view of a seasonal spring joined by trails through the wetlands and rainforest (young Sitka spruce and western hemlock) of the park.

The park also includes about 13 miles of hiking trails including the Fort to Sea Trail.

During the summer, living history programs, ranger-led hikes, and a canoeing program enhance the story of this historically significant expedition.

Code of Conduct

BEHAVIOR EXPECTATIONS AT FORT CLATSOP

- Adults and youth need to stay together, even if only going into the restroom; use the "buddy system."
- Stay on sidewalks or trails. Our rainforest is home to many plants and animals.
- Remember, this is a National Park Service site, so leave plants, animals, fungi, etc. in place and in the same condition as found.
- Please walk do not run. This reduces accidents.
- Keep voices down. Sound travels surprisingly well here.
- Keep feet on the ground or floor (no climbing). It is fine to sit on a lower bunk bed at the fort, but do not climb to a top bunk.
- Please be polite and courteous to others in the park.
- Bookstore: At least one adult should accompany up to four youth in the bookstore. If no other visitors are in the bookstore area, ask if more may shop at one time.
- Please assist in keeping Lewis and Clark National Historical Park, Fort Clatsop a beautiful park. Report littering and vandalism.
- Have fun exploring your park and learning about the Corps of Discovery's winter at Fort Clatsop!



ADDITIONAL ADVENTURES IN THE AREA

If your scouts would like to earn the Lewis and Clark Trail Heritage patch, please see the attached flyer (ORLOTHF-BSA-Patch-9-2010).

Requirement #1 would be complete by adding a stop at Lewis and Clark's salt works in Seaside, which is approximately 7 miles south of Camp Rilea. This is where the Corps of Discovery made the salt that preserve their meat and fish. The salt works are a few blocks west of Highway 101, at 56 Lewis and Clark Way, Seaside, OR 97138.

The wreck of the Peter Iredale is about 7 miles away at Fort Stevens State Park. The ship ran aground in a thick fog in 1906. Now only its steel hull remains as an eerie reminder of the extreme dangers of the Columbia River bar — which is known as the "graveyard of the Pacific."

From Camp Rilea, take 101 north briefly to Hwy 104 and follow the signs to Fort Stevens.
